A minister with Dual Standing is responsible for any requirements of maintaining standing in the United Church of Christ as established by the Committee on Ministry for its ministers (such as boundary awareness training, anti-racism training, and attendance at Association and Conference annual meetings). Not maintaining the requirements for standing may result in the removal of Dual Standing. Requirements are:

- 1. Attending Annual Meeting,
- 2. Boundary Training every three years and
- 3. Submission of the yearly Annual Information Review.

Non-fulfillment of these requirements may result in removal of Dual Standing. The Committee on Ministry will increase requirements as Continuing Educations needs are decided. Diversity, Inclusion and Equity will start being required in 2023.

Oversight for ministers with Dual Standing is held primarily in the denomination of origin. If a fitness concern is raised regarding an ordained minister with Dual Standing, the originating denomination must be made aware at the onset.

If a fitness concern is raised regarding the minister with Dual Standing, the originating denomination must be made aware at the onset. The 2018 Manual on Ministry guidelines for Fitness review of the minister will be followed and are found on page 48-49.

The Fellowship of Affirming Ministries (TFAM) ministers will follow the Dual Standing protocol or the Ordained Ministerial Standing path. The Committee on Ministry will approve Dual Standing, Privilege of Call or Member in Discernment status from the Manual on Ministry p.42
