### PRIVILEGE OF CALL INTERVIEW PROCESS

At times, ordained ministers from other Christian denominations seek to affiliate their lives and ministries with the United Church of Christ. The process of Privilege of Call is designed for an ordained minister who desires to leave their denomination of original authorization and become an Ordained Minister in the United Church of Christ.

There are times when it is appropriate for a Committee on Ministry to grant Member in Discernment status rather than Privilege of Call status, particularly if the person's previous ordination is granted by a non-denominational entity (e.g. local congregation or online organization) and/or if the person does not adequately demonstrate the Marks of Faithful and Effective Authorized Minsters.

There are cases in which a letter of good standing from the current denomination is not available to the Committee on Ministry. Frequently unavailability is because or the gender non-conformity, sexual ID or theology supportive of the LGBTQ+ Community of the minister. In these instances, it is incumbent upon the Committee to verify that there are no prior or ongoing ecclesiastical proceedings that would deem the minister unfit for standing in the United Church of Christ. Efforts in this regard should be well-documented and maintained in the minister's file.
